The Repeal and Replacement of Obamacare

Recently the House passed a bill in an attempt to repeal and replace some aspects of the Affordable Care Act (Obamacare), and **Dr. Dennis Haghghat**, CEO of Victor Valley Global Medical Center was on hand to share some of the aspects of the proposed changes and how they may affect us not only personally, but in business as well.

One of the biggest changes would be the Individual Mandate. Under Obamacare, The Affordable Care Act requires everyone to obtain health insurance or face tax penalties. This was meant to keep insurance affordable for those who are older or sick.

The new version would eliminate the individual mandate, which means that people would not have to pay a penalty if they went without insurance. One possible effect, though, is that healthy people might be less likely to buy insurance, driving up prices for those

who need it most, like the elderly and those with pre-existing conditions. To assist in this, the plan proposes a "continuous coverage incentive," which would charge people in the individual market a 30 percent penalty for lapses in health insurance coverage.


Another repeal would be subsidies for out-of-pocket expenses. With Obamacare, The federal government provides tax credits to help some people pay deductibles and make co-payments. In the new Bill, this cost sharing subsidy would end in 2020.

In the area of changes, one of the largest is overall health benefits. Since 2010, all insurers must offer 10 essential health benefits, including maternity care and preventive services, but that would change if the new version becomes law. In the new version, each state would define its own set of essential health benefits beginning in 2018, rather than making it a federal requirement.

Another change would be premium subsidies. Today, the federal government provides tax credits to middle-income Americans on a sliding scale according to income, to help offset the cost of premiums. The new version would change the way subsidies are distributed by using age, instead of income, as a way to calculate how much people receive. Tax credits would be available in full to individuals earning less than \$75,000 and households earning less than \$150,000, but they would be capped for higher earners. The subsidy would be \$2,000 for a person under 30, and double that for people over 60. The bill would also expand the health plans that qualify for subsidies. It would also allow people to deduct more health care expenses from their income taxes.

Of course all this is contingent on what happens when the Bill goes through the Senate next week. It could pass or go back and forth with changes for quite some time.
