

The Perception and Reality of Homelessness

The perception of the homeless is that of a person who is sadly down on their luck, but the reality, according to **Deputy Asiah Medawar**, is that most of the transients that she has to deal with are drug addicts, violent and criminals. There are two types of homeless people, the Episodic Homeless, who are truly trying to get off the street and re-start their lives, and the Chronically Homeless, who view it as a way of life. The latter type of transients are the dangerous ones.

The homeless who are day to day usually work with the H.O.P.E. Program (Homeless Outreach Proactive Enforcement) to make changes, but the homeless that causes trouble usually suffer from family struggles, mental disorders, drug addiction, acquire a lot of trash, commit crimes and actually enjoy the freedom of being homeless. For the last two years, the Downtown and Mall areas are the highest points of calls for trouble. It has become so rampant, that the San Bernardino County Sheriffs Department has assigned two deputies specifically to answer calls for this issue. Most of the calls they have to deal with on any given day are trespassing, panhandling and public intoxication.

The biggest issue they have to deal with is that people who call do not want to leave a name or file a report, out of fear of retribution. If no one stands up and files charges, then

First, make sure you have signs posted around your business that say "No Trespassing" or "No Loitering". There is also a Trespass Agreement that a business can file with the City of Victorville. Doing these allows deputies to act as an agent for your business, and make the proper arrests as needed. Deputy Medawar also advised to not give handouts, allow them to do something in your company in exchange for food or drink, keep your business well lit, and make sure your trash bins are kept secure.

Although, a transient will only serve 8 hours in jail, if they are arrested it will serve as a deterrent to not return to your location, and to find another place to take themselves. If we keep trying to ignore them, and not sign citizen arrest forms. there are no repercussions to them and no reason to move on, as they seem to be creatures of habit.

Please be visual and do not be afraid to call for help.
